Annual Dues Schedule – Fiscal Year 2022-23

Individual Member dues shall be \$67.00 per year.

Associate Member dues shall be \$138.00 per year for any not-for-profit or government agency, organization, or company and \$225.00 per year for any other agency, organization, or company.

Agency Member dues shall be comprised of the sum of the following components applicable to the Agency Member.

- a. Administrative Fee of \$277.00 per year.
- b. POTW discharge fee calculated as \$2,177.71 per MGD of POTW average design capacity for those Agency Members owning or operating a POTW with an NPDES permit to discharge into the three watersheds.
- c. Acreage fee calculated as \$0.7645 per acre for all of the acreage within the corporate limits of a municipality which is tributary to the three watersheds and for the unincorporated acreage within a county which is tributary to the three watersheds.
